Introduction to integration provides a unified account of integration theory, giving a practical guide to the Lebesgue integral and its uses, with a wealth of illustrative examples and exercises. The book begins with a simplified Lebesgue-style integral (in lieu of the more traditional Riemann integral), intended for a first course in integration. This suffices for elementary applications, and serves as an introduction to the core of the book. The final chapters present selected applications, mostly drawn from Fourier analysis. The emphasis throughout is on integrable functions rather than on measure. The book is designed primarily as an undergraduate or introductory graduate textbook. It is similar in style and level to Priestley's Introduction to complex analysis, for which it provides a companion volume, and is aimed at both pure and applied mathematicians. Prerequisites are the rudiments of integral calculus and a first course in real analysis.

Complex Analysis with Applications

With this second volume, we enter the intriguing world of complex analysis. From the first theorems on, the elegance and sweep of the results is evident. The starting point is the simple idea of extending a function initially given for real values of the argument to one that is defined when the argument is complex. From there, one proceeds to the main properties of holomorphic functions, whose proofs are generally short and quite illuminating: the Cauchy theorems, residues, analytic continuation, the argument principle. With this background, the reader is ready to learn a wealth of additional material connecting the subject with other areas of mathematics: the Fourier transform treated by contour integration, the zeta function and the prime number theorem, and an introduction to elliptic functions culminating in their application to combinatorics and number theory. Thoroughly developing a subject with many ramifications, while striking a careful balance between conceptual insights and the technical underpinnings of rigorous analysis, Complex Analysis will be welcomed by students of mathematics, physics, engineering and other sciences. The Princeton Lectures in Analysis represents a sustained effort to introduce the core areas of mathematical analysis while

also illustrating the organic unity between them. Numerous examples and applications throughout its four planned volumes, of which Complex Analysis is the second, highlight the far-reaching consequences of certain ideas in analysis to other fields of mathematics and a variety of sciences. Stein and Shakarchi move from an introduction addressing Fourier series and integrals to in-depth considerations of complex analysis; measure and integration theory, and Hilbert spaces; and, finally, further topics such as functional analysis, distributions and elements of probability theory.

Complex Variables for Scientists and Engineers

This second edition presents a collection of exercises on the theory of analytic functions, including completed and detailed solutions. It introduces students to various applications and aspects of the theory of analytic functions not always touched on in a first course, while also addressing topics of interest to electrical engineering students (e.g., the realization of rational functions and its connections to the theory of linear systems and state space representations of such systems). Complex Analysis

Complex analysis is one of the most central subjects in mathematics. It is compelling and rich in its own right, but it is also remarkably useful in a wide variety of other mathematical subjects, both pure and applied. This book is different from others in that it treats complex variables as a direct development from multivariable real calculus. As each new idea is introduced, it is related to the corresponding idea from real analysis and calculus. The text is rich with examples and exercises that illustrate this point. The authors have systematically separated the analysis from the topology, as can be seen in their proof of the Cauchy theorem. The book concludes with several chapters on special topics, including full treatments of special functions, the prime number theorem, and the Bergman kernel. The authors also treat H^p spaces and Painlevé's theorem on smoothness to the boundary for conformal maps. This book is a text for a first-year graduate course in complex analysis. It is an engaging and modern introduction to the subject, reflecting the authors' expertise both as mathematicians and as expositors.

Introduction to Integration

In 2007 Terry Tao began a mathematical blog to cover a variety of topics, ranging from his own research and other recent developments in mathematics, to lecture notes for his classes, to nontechnical puzzles and expository articles. The first two years of the blog have already been published by the American Mathematical Society. The posts from the third year are being published in two volumes. The present volume consists of a second course in real analysis, together with related material from the blog. The real analysis course assumes some familiarity with general measure theory, as well as fundamental notions from undergraduate analysis. The text then covers more advanced topics in measure theory, notably the Lebesgue-Radon-Nikodym theorem and the Riesz representation theorem, topics in functional analysis, such as Hilbert spaces and Banach spaces, and the study of spaces of distributions and key function spaces, including Lebesgue's L^p spaces and Sobolev spaces. There is also a discussion of the general theory of the Fourier transform. The second part of the book addresses a number of auxiliary topics, such as Zorn's lemma, the Carathéodory extension theorem, and the Banach-Tarski paradox. Tao also discusses the epsilon regularisation argument—a fundamental trick from soft analysis, from which the book gets its title. Taken together, the book presents more than enough material for a second graduate course in real analysis. The second volume consists of technical and expository articles on a variety of topics and can be read independently.

Introduction to Analysis

Analysis is a core subject in most undergraduate mathematics degrees. It is elegant, clever and rewarding to learn, but it is hard. Even the best students find it challenging, and those who are unprepared often find it incomprehensible at first. This book aims to ensure that no student need be unprepared.

Function Theory of One Complex Variable

Describing two cornerstones of mathematics, this basic textbook presents a unified approach to algebra and geometry. It covers the ideas of complex numbers, scalar and vector products, determinants, linear algebra, group theory, permutation groups, symmetry groups and aspects of geometry including groups of isometries, rotations, and spherical geometry. The book emphasises the interactions between topics, and each topic is constantly illustrated by using it to describe and discuss the others. Many ideas are developed gradually, with each aspect presented at a time when its importance becomes clearer. To aid in this, the text is divided into short chapters, each with exercises at the end. The related website features an HTML version of the book, extra text at higher and lower levels, and more exercises and examples. It also links to an electronic maths thesaurus, giving definitions, examples and links both to the book and to external sources.

An Epsilon of Room, I: Real Analysis

This self-contained introduction to algebraic topology is suitable for a number of topology courses. It consists of about one quarter 'general topology' (without its usual pathologies) and three quarters 'algebraic topology' (centred around the fundamental group, a readily grasped topic which gives a good idea of what algebraic topology is). The book has emerged from courses given at the University of Newcastle-upon-Tyne to senior undergraduates and beginning postgraduates. It has been written at a level which will enable the reader to use it for self-study as well as a course book. The approach is leisurely and a geometric flavour is evident throughout. The many illustrations and over 350 exercises will prove invaluable as a teaching aid. This account will be welcomed by advanced students of pure mathematics at colleges and universities.

Algebra and Geometry

Discovered at the turn of the 20th century, p-adic numbers are frequently used by mathematicians and physicists. This text is a self-contained presentation of basic p-adic analysis with a focus on analytic topics. It offers many features rarely treated in introductory p-adic texts such as topological models of p-adic spaces inside Euclidean space, a special case of Hazewinkel's functional equation lemma, and a treatment of analytic elements.

A First Course in Algebraic Topology

This unique textbook provides the foundation for understanding and applying techniques commonly used in geophysics to process and interpret modern digital data. The geophysicist's toolkit contains a range of techniques which may be divided into two main groups: processing, which concerns time series analysis and is used to separate the signal of interest from background noise; and inversion, which involves generating some map or physical model from the data. These two groups of techniques are normally taught separately, but are here presented together as parts I and II of the book. Part III describes some real applications and includes case studies in seismology, geomagnetism, and gravity. This textbook gives students and practitioners the theoretical background and practical experience, through case studies, computer examples and exercises, to understand and apply new processing methods to modern geophysical datasets. A Course in p-adic Analysis

The Portable, Extensible Toolkit for Scientific Computation (PETSc) is an open-source library of advanced data structures and methods for solving linear and nonlinear equations and for managing discretizations. This book uses these modern numerical tools to demonstrate how to solve nonlinear partial differential equations (PDEs) in parallel. It starts from key mathematical concepts, such as Krylov space methods, preconditioning, multigrid, and Newton's method. In PETSc these components are composed at run time into fast solvers. Discretizations are introduced from the beginning, with an emphasis on finite difference and finite element methodologies. The example C programs of the first 12 chapters, listed on the inside front cover, solve (mostly) elliptic and parabolic PDE problems. Discretization leads to large, sparse, and generally nonlinear systems of algebraic equations. For such problems, mathematical solver concepts are explained and

illustrated through the examples, with sufficient context to speed further development. PETSc for Partial Differential Equations addresses both discretizations and fast solvers for PDEs, emphasizing practice more than theory. Well-structured examples lead to run-time choices that result in high solver performance and parallel scalability. The last two chapters build on the reader's understanding of fast solver concepts when applying the Firedrake Python finite element solver library. This textbook, the first to cover PETSc programming for nonlinear PDEs, provides an on-ramp for graduate students and researchers to a major area of high-performance computing for science and engineering. It is suitable as a supplement for courses in scientific computing or numerical methods for differential equations.

Time Series Analysis and Inverse Theory for Geophysicists

Complex Function Theory is a concise and rigorous introduction to the theory of functions of a complex variable. Written in a classical style, it is in the spirit of the books by Ahlfors and by Saks and Zygmund. Being designed for a one-semester course, it is much shorter than many of the standard texts. Sarason covers the basic material through Cauchy's theorem and applications, plus the Riemann mapping theorem. It is suitable for either an introductory graduate course or an undergraduate course for students with adequate preparation. The first edition was published with the title Notes on Complex Function Theory.

Complex Function Theory

This introduction to complex variable methods begins by carefully defining complex numbers and analytic functions, and proceeds to give accounts of complex integration, Taylor series, singularities, residues and mappings. The emphasis is laid on understanding the use of methods, rather than on rigorous proofs. Throughout the text, many of the important theoretical results in complex function theory are followed by relevant and vivid examples in physical sciences. Material has been updated and additional proofs on some of the important theorems in complex function theory are now included, e.g. the Weierstrass–Casorati theorem. This book is based on a first-year graduate course I gave three times at the University of Chicago. As it was addressed to graduate students who intended to specialize in mathematics, I tried to put the classical theory of functions of a complex variable in context, presenting proofs and points of view which relate the subject to other branches of mathematics. Complex analysis in one variable is ideally suited to this attempt. Of course, the branches of mathematics one chooses, and the connections one makes, must depend on personal taste and knowledge. My own leaning towards several complex variables will be apparent, especially in the notes

at the end of the different chapters. The first three chapters deal largely with classical material which is available in the many books on the subject. I have tried to present this material as efficiently as I could, and, even here, to show the relationship with other branches of mathematics. Chapter 4 contains a proof of Picard's theorem; the method of proof I have chosen has far-reaching generalizations in several complex variables and in differential geometry. The next two chapters deal with the Runge approximation theorem and its many applications. The presentation here has been strongly influenced by work on several complex variables.
